There he held various managerial positions before he was appointed Managing Director of Vaillant Germany in May 2009. Since September 2010 Dr Groos has in addition to this task

been Regional Director of the Vaillant Group's Sales, Marketing and Service activities in Central Europe. Dr Groos is married and has three children.

His successor as Regional Director Sales, Marketing and Service Central Europe and Managing Director Vaillant Germany, Dr Tillmann von Schroeter, has worked in various managerial positions at the Vaillant Group since 2006.
